1. The following candidates are invited to appear for Personal Interview on 17th January, 2019 (Thursday) at 10:00 AM at SJVN Ltd., Shakti Sadan, Shanan, Shimla (H.P.)-171006.
2. The following documents in original with one clear Photostat copy duly attested / self attested needs to be produced at the time of Personal Interview without which candidate will not be allowed to attend the interview:
 - a) Personal Resume in the prescribed format (sent along with call letter) duly completed in all respects with photograph affixed.
 - b) Proof of date of birth certificate/ Matric Certificate mentioning the date of birth.
 - c) 10th Pass certificate & Mark sheet.
 - d) 12th Pass Certificate & Mark sheet.
 - e) Graduation Certificate with mark sheets.
 - f) Certificate and mark sheets of the qualification which makes you eligible i.e. graduate with three years full time graduate Degree in Law from a recognized University/ Institute with aggregate marks of not less than 50%.
 - g) Master's Degree certificate (if applicable) with mark sheets.
 - h) Higher qualification Certificate, if any, with mark sheets.
 - i) If applicable - SC/ST Certificate in prescribed format.
 - j) If applicable OBC - valid Non-creamy Layer Certificate **issued on or after 1st July, 2018**, for appointment to posts in Central Government / Central Government Undertaking, in the prescribed format, duly signed by competent authority.
 - k) PWD Certificate indicating Percentage of disability & Type of disability issued by competent authority in the prescribed format.
 - l) NOC from the employer, in case employed in Government / PSU.
3. You are called provisionally, subject to your fulfilling eligibility criteria outlined in our advertisement such as having completed Graduate with three years full time graduate Degree in Law for Law discipline and Graduate with Two years full time Post-Graduate

Degree in Hindi with English as a subject for Official Language discipline from a recognised University / Institute of India with aggregate marks of not less than 50%. The upper age limit is 40 years for General Category PWDs, 43 years for OBC PWDs and 45 years for SC/ST category PWDs, after allowing relaxation of 10, 13 & 15 years to respective categories. The age will be calculated as on closing date of the advertisement. Those who do not fulfill the criteria should not attend the interview.

4. Only such candidates would be eligible for the Posts of ET (Law /OL) Disciplines who are visually handicapped and suffer from not less than 40% of permanent disability. The candidates will have to submit a Disability certificate issued by a Competent Authority in the prescribed format as per directives of Govt. of India.
5. Single to and fro 2nd Class AC Rail Fare by Ordinary Train / Bus by the shortest route from the above address or the place of actual travel, whichever is nearer to the place of interview, will be reimbursed on production of tickets. No Local Conveyance expenses will be paid.
6. In case of the interview spilling over to next day owing to unavoidable circumstances, no halting and / or accommodation or any expenses thereof will be payable.
7. Wherever SGPA / CGPA or letter grade in Degree / Post grade is awarded, equivalent percentage of marks should be verifiable as per norms adopted by University/ Institute. Please also obtain a certificate to this effect from the University / Institute, which shall be required at the time of Personal interview.
8. You may choose to give interview in Hindi.
9. No request for change of interview date or venue shall be entertained.
10. Canvassing directly or indirectly will disqualify the candidature
